**ORDINANCE NO. 5810**, October 30, 2023

WHEREAS, the Prosecuting Attorney's Office desires to purchase replacement furniture and to dispose of surplus furniture using an existing term and supply vendor; and,

WHEREAS, by Resolution 21146, dated February 7, 2023, a term and supply contract was awarded to Office Products Alliance of Kansas City (Jackson County), MO under Invitation to Bid No. 109-22 for the furnishing of office furniture; and,

WHEREAS, an appropriation is necessary to place funds available in the Undesignated fund balance of the Prosecuting Attorney's Delinquent Sales Tax Fund in the proper spending account; now therefore,
