BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the property within the Circuit Court, Assessment, and Parks and Recreation Departments, further described and itemized in Exhibits A, B, and C be and hereby is declared surplus, and that the Director of Finance and Purchasing be and hereby is authorized to dispose of it by auction or otherwise, pursuant to chapter 11, Jackson County Code, 1984.
