AN ORDINANCE authorizing the County Executive to award contracts for the removal and storage of the Andrew Jackson statues on the grounds of the Downtown and Historic Truman Courthouses and for site repairs of any damages occasioned by the removal.

ORDINANCE NO. 5375, July 13, 2020

INTRODUCED BY Jalen Anderson, County Legislator

WHEREAS, in view of recent developments including damage caused to the statue of Andrew Jackson on the grounds of the Downtown Courthouse, it is appropriate that the statues of Andrew Jackson at the Downtown and Historic Truman Courthouses be removed and stored while decisions concerning the statutes' ultimate location and fate are contemplated; and,

WHEREAS, in order to expedite the removal and storage, it is appropriate that the County Executive

be authorized to award contracts for these services, as well as for the repair of any damages to the

Courthouses' grounds occasioned by the removal; and,

WHEREAS, in awarding these contracts, the County Executive shall follow the competitive

procedures set out in chapter 10 of the Jackson County Code; and,

WHEREAS, the County Executive may only expend funds for such contracts as are budgeted in

appropriate spending accounts or properly transferred under the provisions of chapter 5 of the code;

now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the County Executive

be and hereby is authorized to award contracts for the removal and storage of the statutes of Andrew

Jackson on the grounds of the Downtown and Historic Truman Courthouses and for site repairs of

any damages to the Courthouses' grounds occasioned by the removal, on the terms set out in the

Ordinance.

Effective Date: This ordinance shall be effective immediately upon its signature by the County

Executive.
