A RESOLUTION congratulating Brian Rauscher upon his championship at the 1998 Missouri State Swimming and Diving Tournament.

RESOLUTION # 12110, March 16, 1998

INTRODUCED BY John C. Graham and Fred Arbanas, County Legislators

WHEREAS, Brian Rauscher, Lee's Summit High School senior, capped his high school swimming career by winning the 200-yard freestyle event with a time of 1 minute, 42.62 seconds, at the 1998 Missouri State Swimming and Diving Tournament; and,

WHEREAS, his time came close to the state record of 1:40:40 and he finished ahead of the second place swimmer by two seconds; and,

WHEREAS, Brian, who was undefeated for the season, became the first swimmer from Jackson County in two years to win a championship at the state tournament; and,

WHEREAS, Brian not only broke the school record in the 200-yard freestyle but went on to break another school record in the 100-yard freestyle event, finishing third with a time of 47.93, only one second behind the champion; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature congratulates Lee's Summit High senior Brian Rauscher upon his outstanding victory at the 1998 Missouri State Swimming and Diving Tournament...Attorney Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
