ORDINANCE #3241, April 2, 2002

WHEREAS, the Parks and Recreation Department has been awarded a grant in the amount of \$95,280.00 by the Missouri Division of State Parks for the renovation of trails at the Longview Horse Park; and,

WHEREAS, these funds are subject to a local match in the amount of \$63,520.00; and,

WHEREAS, the Longview Horse Park Association has agreed to provide the local match in the form of a \$40,320 grant and \$23,200 in in-kind contributions of goods and services; and,

WHEREAS, appropriations are necessary in order to place the grant and matching funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends these appropriations as amendments to her proposed 2002 County budget; and,

WHEREAS, the attached Project Agreement with the Missouri Division of State Parks adequately sets out rights and responsibilities of the parties with regard to this grant program; now therefore,
