WHEREAS, by Ordinance 2842, dated August 31, 1998, and Ordinance 2745 dated October 13, 1997, as amended by Resolution 12159 dated April 6, 1998, the Legislature approved cooperative agreements with the City of Kansas City, MO, as to the Local Law Enforcement Block Grant; and,

WHEREAS, the City of Kansas City now desires to amend said agreements by extending the date of each contract until May 31, 1999; and,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to enter into the attached addendums, copies of which are incorporated herein by reference, with the City of Kansas City, MO; and,

BE IT FURTHER RESOLVED that the Director of Finance be, and hereby is, authorized to make all payments, including final payment on this Agreement to the extent sufficient appropriations to the using spending agency are included in the current Jackson County budget...Attorney Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
