INTRODUCED BY Theresa Garza Ruiz, County Legislators

WHEREAS, pursuant to section 205.630, RSMo, the County is required to cover the burial expense of individuals who die within the County and have no means of paying a burial expense; and,

WHEREAS, due to the insolvency of the County's contracted indigent burial provider, a transfer is

necessary to cover the cost of indigent burial fees through the remainder of 2011 that have unexpectedly exceeded budgetary projections; and,

WHEREAS, the County Executive recommends this transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer within the 2011 Health Fund be and hereby is made:
