BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the attached easement agreements are hereby approved and that the County Executive is hereby authorized to execute the agreements on behalf of the County...Attorney Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
