ORDINANCE # 3188, September 24, 2001

INTRODUCED BY Fred Arbanas, County Legislator

WHEREAS, the Parks and Recreation Department has received a Corps of Discovery grant from the State of Missouri's Lewis and Clark Bicentennial Commission in the amount of \$23,500.00, for initial architectural services in connection with the proposed Education Center at the Fort Osage National Historic Landmark; and,

WHEREAS, the total estimated cost of the project is \$47,000.00; and,

WHEREAS, the Commission will reimburse \$23,500.00; and,

WHEREAS, a transfer and appropriation are necessary to place the grant funds and required matching funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends this transfer and appropriation; now therefore,
