### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** appropriating \$455,000.00 from the fund balance of the 2010 General Fund to cover the costs of salaries in the Department of Corrections.

**ORDINANCE #4191**, February 8, 2010

**INTRODUCED BY** Scott Burnett, County Legislator

WHEREAS, by Resolution 17124, dated December 11, 2009, the Legislature did authorize the acceptance of \$455,000.00 from the sale of right of way near the Sports Complex to the Missouri Department of Transportation; and,

WHEREAS, the Department of Corrections was required to reduce their 2010 General Fund budget by approximately \$823,000.00; and,

WHEREAS, appropriating these funds to Corrections will allow the department to sufficiently staff and provide basic inmate services to the same population served in 2009; and,

WHEREAS, an appropriation is necessary to place the funds in the appropriate spending accounts; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:
