AN ORDINANCE appropriating \$43,676.00 within the 2009 Sheriff's Conceal & Carry Weapon Fund for the creation of one new clerical position in the Sheriff's Office.

ORDINANCE #4122, July 20, 2009

INTRODUCED BY Theresa Garza Ruiz, County Legislator

WHEREAS, section 50.535 of Missouri Revised Statutes states that the fees collected to process concealed carry permit applications will be placed in a separate interest-bearing fund, and may be used specifically for equipment, training, and other necessary expenditures to process applications

including employment of additional personnel; and,

WHEREAS, the Sheriff has directed the creation of one new clerical position responsible for the full-time processing of Concealed Carry Permits, and has directed the use of use the Conceal & Carry Weapon Fund for the position's salary; and,

WHEREAS, an appropriation is necessary in order to place the money in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:
