INTRODUCED BY James D. Tindall, County Legislator

WHEREAS, the City of Lee's Summit, MO, is desirous of having the Sheriff of Jackson County, Missouri, provide additional law enforcement presence in other areas of the City traveled by Sheriff's deputies while performing their official duties; and,

WHEREAS, the County has the resources and the manpower to provide this additional law enforcement presence; and,

WHEREAS, the attached Intergovernmental Cooperative Agreement sets forth mutual understandings and obligations of the City and County with regards to the cooperative effort regarding the additional law enforcement presence; and,

WHEREAS, this Agreement is in the best interest of the health, welfare, and safety of the citizens of the County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute an Intergovernmental Cooperative Agreement with the City of Lee's Summit, Missouri, in a form similar to the attached agreement, for additional law enforcement presence in areas of the City.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
