IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION authorizing the County Executive to enter into a contract with the Jackson County Sports Authority and the Kansas City Royals Baseball Corporation.

RESOLUTION # 12322, August 25, 1998

INTRODUCED BY Victor E. Callahan, County Legislator

WHEREAS, the Jackson County Sports Authority and Kansas City Royals Baseball Corporation entered into a new 25 year Lease on January 19, 1990 (the Lease) which included an agreement by the Authority to perform certain Master Plan repairs and improvement as more fully described in Exhibit 1 to the Lease; and,

WHEREAS, section 3.03 (b) of the lease provides that the Royals will meet on an annual basis to evaluate and update the Master Plan, including the establishment of scheduling priorities for improvements to be made at the Sports Complex; and,

WHEREAS, meetings have been held between the Authority and Royals to discuss the costs and timing of Master Plan Improvements; and,

WHEREAS, the revised list of Master Plan improvement priorities, attached hereto as Exhibits A, B, C and 1 was agreed to; and,

WHEREAS, the Lease further requires that the Royals and the Authority are to approve the updated Master Plan in writing and the Authority approves same at a regular monthly meeting; and,

WHEREAS, the Jackson County Sports Authority and the Kansas City Royals Corporation agree that it is in the best interest of the Jackson County Sports Authority and the Kansas City Royals Baseball Corporation to agree upon and formally establish in writing the status of the Master Plan Projects at the conclusion of year nine (9) of the Master Plan; and,

WHEREAS, the Authority pursuant to Resolution No. 98.52 has adopted the Master Plan Updates as set out in Exhibits A, B, C and 1; and,

WHEREAS, Jackson County, Missouri shall by this Resolution give its written consent and agreement to the Master Plan update; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County gives its written consent and agreement to the Master Plan Update as set forth in Exhibits A, B, C and 1; and,

BE IT FURTHER RESOLVED that the that the County Executive is hereby authorized to sign the County Consent and Agreement between the Kansas City Royals Baseball Corporation, the County, and the Jackson County Sports Authority...Attorney
