RESOLUTION 12425, November 16, 1998

INTRODUCED BY John Patrick Burnett, County Legislator

WHEREAS, the County did, by Resolution 7668, dated November 28, 1988, enter into a maintenance and service contract with Intergraph Corporation in the amount of \$18,360.00; and,

WHEREAS, this contract has been extended on an annual basis since that time; and,

WHEREAS, the County now desires to extend this service contract as is necessary to provide continued maintenance for the year 1999, and this extension will not exceed \$27,957.26; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the extension to the aforesaid contract is approved and the Director of Purchasing is authorized to execute the necessary documents on behalf of the County; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract...Attorney

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
