A RESOLUTION authorizing the County Executive to execute a Second Addendum to the contract with Health Productivity Systems of Kansas City, MO for the furnishing of urinalysis testing for use by the Prosecuting Attorney's Deferred Prosecution and Drug Court, in the estimated amount of \$160,000.00 and extending the term for a period of 12 months.

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, by Resolution 12950, dated November 22, 1999, the Legislature authorized a contract with Health Productivity Systems of Kansas City, MO, for the furnishing of urinalysis testing for use by the Prosecuting Attorney's Deferred Prosecution and Drug Court programs; and,

WHEREAS, by First Addendum to Agreement dated September 5, 2000, the terms of said contract were extended; and,

WHEREAS, the Prosecuting Attorney has recommended an increase to this contract in the amount of \$160,000.00, and that the term of this Agreement be extended through July 31, 2002, in order to allow Health Productivity Systems to continue providing urinallysis services to participants of the Deferred Prosecution and Drug Court programs; and,

WHEREAS, the attached Second Addendum to Agreement provides a suitable mechanism by which to implement the Prosecuting Attorney's recommendation in this regard; therefore,

BE IT FURTHER RESOLVED that the Director of the Department of Finance be and hereby is authorized to make all payments on the Agreement, as amended.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
