WHEREAS, while not the lower bid, the lowest and best bid received was from Deffenbaugh Industries d/b/a Johnny On The Spot of Shawnee, KS as set out in the attached documentation; and,

WHEREAS, the Purchasing Director has recommended that award be made to Deffenbaugh Industries d/b/a Johnny On The Spot of Shawnee, KS, for the reason that it has submitted the lowest and best bid; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agency have heretofore been made in the current Jackson County budget.
