IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a term and supply contract on Bid No. 87-98 for the furnishing of trash removal service for use county-wide to Deffenbaugh Disposal of Shawnee Mission, KS (\$50,629.80), Cass County Disposal of Harrisonville, MO (\$2,740.40), and Waste Management of K. C. of Independence, MO (\$21,621.60), to provide for county-wide needs for the upcoming one-year period, in the estimated aggregate amount of \$74,991.80.

WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 87-98 for the furnishing of trash removal service for use county-wide; and,

WHEREAS, following evaluation of the bids submitted, the Purchasing Director recommends the contract be divided and awarded to the vendors submitting the lowest bid for each location to be served; and,

WHEREAS, awarding as recommended would result in the estimated amounts for the respective vendors as follows:
