A RESOLUTION awarding a term and supply contract on Bid No. 131-97 for the furnishing of printed letterhead stationery, envelopes, and business cards for use county-wide to Service Printing & Graphics of Kansas City, MO (\$24,200.00), Frank Moses Litho Co. of Kansas City, MO (\$12,100.00), Quality Printing of Lenexa, KS (\$8,800.00), Parsons Graphics of Shawnee Mission, KS (\$6,600.00), and Brian Pollmiller & Associates of Shawnee, KS (\$6,600.00), to provide for county-wide needs for the upcoming one-year period, in the estimated aggregate amount of \$58,300.00.
