authorized to execute for the County any documents necessary to the accomplishment of the award;

BE IT FURTHER RESOLVED that the Director of Public Works is authorized to approve line item

adjustments which may become necessary under this contract to the extent there is no additional

cost to the County; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all

payments, including final payment on the contract.
