## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** appropriating \$56,477.00 from the unappropriated surplus of the 2005 Grant Fund in acceptance of a grant awarded to the Family Court Division by the Missouri Department of Public Safety for the Victim Advocacy program.

**ORDINANCE # 3682**, September 19, 2005

WHEREAS, the Missouri Department of Public Safety has awarded a grant in the amount of \$56,477.00 to the Family Court Division of the Circuit Court of Jackson County, Missouri for the Victim Advocacy Program; and,

WHEREAS, the Victim Advocacy program provides services to children and their non-offending family members seen at the Child Protection Center, a project of Jackson County Family Court Services; and,

WHEREAS, comprehensive services for the Victim Advocacy program will include crisis intervention, follow-up, referral and linkage to therapy and other needed community services, and support and advocacy throughout the investigation and any medical or court proceedings; and,

WHEREAS, the term of this grant is from July 1, 2005 through June 30, 2006; and,

WHEREAS, an appropriation of \$56,477.00 is required in order to place the grant monies in the proper spending accounts for use by the Family Court Division; now therefore,
