WHEREAS, the Purchasing Director has solicited formal written bids on Bid No. 122-99 for a term and supply contract for the furnishing of Terrain King mower hydraulic and mechanical parts for use by the Public Works and Parks and Recreation Departments to provide for departmental needs for the upcoming one-year period; and,

WHEREAS, he has received as the only two bids thereon bids from the following:

WHEREAS, the Purchasing Director has recommended that award be made to Lawn & Leisure of Lee's Summit, MO, for the reason that it has submitted the lowest and best bid; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent sufficient appropriations to the using spending agencies have heretofore been made in the current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
