AN ORDINANCE appropriating \$785,000.00 from the unappropriated surplus of the 1995 Anti-Drug Sales Tax Fund to cover additional requests from outside agencies through the Prosecutor's Office and Fiscal Commission. ORDINANCE #2444, August 21, 1995
