## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** appropriating \$25,100.00 from the fund balance of the 2011 Federal Forfeiture Fund and awarding a twelve-month term and supply contract with two twelve-month options to extend for the furnishing of refurbished laptop computers for use by the Sheriff's Office from Telrepco of Wallingford, CT, under the terms and conditions of Invitation to Bid No. 57-11.

WHEREAS, the Director of Finance and Purchasing has solicited bids on Invitation to Bid No. 57-11 for the furnishing of refurbished laptop computers for use by the Sheriff's Office in its vehicles; and,

WHEREAS, a total of ten notifications were distributed, and three responses were received, as follows:

WHEREAS, the Sheriff has proposed to use federal forfeiture funds to accomplish this purchase; and,

WHEREAS, the U.S. Treasury Department has authorized the use of these funds; and,

WHEREAS, an appropriation is necessary to place the funds in the appropriate spending account; now therefore,
