IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a contract for the purchase of advertising services for use by the Personnel Department to The Kansas City Star Co. of Kansas City, MO, at a cost to the County not to exceed \$10,000.00, as a sole source purchase.

RESOLUTION #12614, March 29, 1999

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, Section 1040.1 of the Jackson County Code, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends a contract with The Kansas City Star Co. of Kansas City, MO, for the purchase of advertising services for use by the Personnel Department; and,

WHEREAS, the Purchasing Director further recommends that it not take competitive bids with regard to said contract for the reason that The Kansas City Star Co. of Kansas City, MO, is the only supplier of advertising services in the Kansas City metropolitan area with a circulation meeting departmental needs; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Purchasing Director be, and hereby is, authorized to execute for the County a contract with The Kansas City Star Co. of Kansas City, MO, for the purchase of advertising services for the Personnel Department, in an amount not to exceed \$10,000.00; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments including final payment on the contract thereby made...Attorney

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
