IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE appropriating \$68,850.00 from the fund balance of the 2010 General Fund and appropriating \$2,520.00 from the fund balance of the 2010 Assessment Fund to cover the cost of janitorial cleaning supplies for use by the Public Works Department.

ORDINANCE #4225, August 16, 2010

INTRODUCED BY Bob Spence, County Legislator

WHEREAS, by Ordinance 4192, dated February 8, 2010, the Legislature did authorize the transition from contracted janitorial services to an in-house program; and,

WHEREAS, the Public Works Department experienced a four (4) month delay in this transition in certain County buildings and it was necessary to continue outside vendor services during this four (4) month period; and,

WHEREAS, an appropriation is necessary to provide adequate funds for cleaning supplies for the balance of the year due to the delay in transition; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:
