WHEREAS, the U.S. Army Corps of Engineers and the County did enter into Lease No. DACW41-1-89-181 for the period of May 9, 1990, through May 8, 2040, for the development of Blue Springs Lake for public parks and recreational purposes; and,

WHEREAS, U.S. Army Corps of Engineers, by document no. DACW41-2-84-14, previously granted the County an easement for the installation, operation, and maintenance of a communications tower within the boundaries of the lease area, which expired on August 16, 2009; and,

WHEREAS, the U.S. Army Corps of Engineers recommends the execution of the attached Supplemental Agreement No. 1 to Lease No. DACW41-1-89-181 for the purpose of adding the communications tower to the existing lease agreement; and,

WHEREAS, the communications tower contains antennas and equipment utilized by the Park Safety and Enforcement Division of the Parks and Recreation Department, the Public Works Department,
