IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a one-year term and supply contract for the furnishing of Hotsy equipment parts and service for use by the Public Works and Parks and Recreation Departments to Hotsy Equipment Company of Kansas City, MO, at an estimated cost to the County of \$5,000.00, as a sole source purchase.

INTRODUCED BY Bob Spence, County Legislator

WHEREAS, Section 1040.1 of the <u>Jackson County Code</u>, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends a contract with Hotsy Equipment Company of Kansas City (Jackson County), MO, in the estimated amount of \$5,000.00, for the furnishing of Hotsy equipment parts and service for use by the Public Works and Parks and Recreation Departments to provide for departmental needs for the upcoming one-year period; and,

WHEREAS, the Purchasing Director further recommends that he not take competitive bids with regard to said contract for the reason that Hotsy Equipment Company of Kansas City, MO is the only factory-authorized supplier of Hotsy equipment parts and service in the Kansas City metropolitan

all payments including final payment on the contract, to the extent sufficient appropriations to the
