### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** awarding a contract for the furnishing of evaluation services for use by COMBAT to the Curators of the University of Missouri - Columbia, under the terms and conditions of Request for Proposals No. 73-11, at a cost to the County not to exceed \$15,723.18.

WHEREAS, COMBAT requires evaluation services on its prevention programs to assure the effectiveness of the programs; and,

WHEREAS, the Director of Finance and Purchasing solicited formal written bids on Request for Proposals No. 73-11 for these services; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments, including final payment, on the contract.
