IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION authorizing the County Executive to execute Cooperative Agreements with Hope House, New House, and Rose Brooks domestic violence shelters in order to provide assistance to victims of domestic violence during 2008, at an aggregate cost to the County not to exceed \$60,000.00.

RESOLUTION #16555, March 3, 2008

INTRODUCED BY Scott Burnett and Theresa Garza Ruiz, County Legislators

WHEREAS, Hope House, New House, and Rose Brooks domestic violence shelters ("Shelters") are not-for-profit organizations providing assistance to victims of domestic violence; and,

WHEREAS, it is in the best interests of the public health, safety, and welfare of the citizens of Jackson County to provide assistance to the victims of domestic violence through funding of these shelters; and,

WHEREAS, pursuant to section 8700., Jackson County Code, 1984, the Board of Domestic Violence Shelters ("Board") was established to administer the distribution of fees collected pursuant to state statutes and the Code; and,

WHEREAS, pursuant to §455.215.2, RSMo, on or before November 15, 2007, the Board or its designee must provide written notification to any domestic violence shelter that has applied for

funding, whether it is eligible to receive funds, and if it is eligible, the amount available from the fees collected; and,

WHEREAS, the Board has met and recommended an allocation of \$60,000.00 of the projected 2008 budget revenues to be divided equally between the three eligible shelters, Hope House, New House, and Rose Brooks, in the amount of \$20,000.00 each after January 1, 2008, and has provided the shelters tentative notification of the same; and,

WHEREAS, the Board will hold a second meeting in June 2008, to recommend allocation of the remaining 2008 revenues based on further revenue projections, for distribution to the three eligible shelters; and,

WHEREAS, the Board recommends that the County Executive be authorized to execute cooperative agreements ("Agreements") effective as of January 1, 2008, in the amount of \$20,000.00 each, at an aggregate cost to the County not to exceed a total of \$60,000.00; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is authorized to execute the Agreements, in a form to be approved by the County Counselor, with Hope House, New House, and Rose Brooks domestic violence shelters for 2008 in the amount of \$20,000.00 each, at a total cost to the County not to exceed \$60,000.00; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments, including final payment on the Agreements.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
