## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** appropriating \$11,952.90 from the fund balance of the 2010 Federal Forfeiture Fund to cover a disbursement from the Western District of Missouri Federal Drug Enforcement Agency for use by the Jackson County Sheriff's Office, and authorizing the County Executive to execute an agreement with the Drug Enforcement Agency to receive and appropriate the funds for education benefits and other equipment.
