A RESOLUTION awarding a contract for the purchase of classified advertising services for use by the Personnel Department to <u>The Kansas City Star</u> Co. of Kansas City, MO, at a cost to the County not to exceed \$14,000.00, as a sole source purchase.

WHEREAS, Section 1040.1 of the Jackson County Code, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends a contract with <u>The Kansas City Star</u> Co. of Kansas City, MO, for the purchase of classified advertising services for use by the Personnel Department; and,

WHEREAS, the Purchasing Director further recommends that it not take competitive bids with regard to said contract for the reason that <u>The Kansas City Star</u> Co. of Kansas City, MO, is the only supplier of classified advertising services in the Kansas City metropolitan area with a circulation meeting departmental needs; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Purchasing Director be, and hereby is, authorized to execute for the County a contract with <u>The Kansas City Star</u> Co. of Kansas City, MO, for the purchase of classified advertising services for the Personnel Department, in an amount not to exceed \$14,000.00; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments including final payment on the contract thereby made.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
