### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** appropriating \$4,605.00 from the unappropriated surplus of the 2006 Grant Fund in acceptance of a grant awarded to the Family Court Division for its Child Protection Center Program by the U.S. Office of Juvenile Justice and Delinquency Prevention and National Children's Alliance, covering expenses for necessary equipment for the program.
