IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION transferring \$32,473.00 within the 2014 Anti-Drug Sales Tax Fund for the creation of a position in the Prosecuting Attorney's Office and authorizing an amendment to the grant award received from the U.S. Department of Justice relating to the 2012 Justice Assistance Grant (JAG).

RESOLUTION NO. 18654, November 3, 3014

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, by Ordinance 4481, dated November 19, 2012, the Legislature did authorize the acceptance of the 2012 Justice Assistance Grant (JAG) in the amount of \$208,000.00, received from the U. S. Department of Justice for the period of October 1, 2011, through September 30, 2015; and,

WHEREAS, the Prosecuting Attorney's Office has requested, and the U.S. Department of Justice has authorized, the reclassification of a staff position title from Violent Crime Offenders Crime Initiative Manager to Data and Information Analyst; and,

WHEREAS, a transfer is needed to complete the funding of this position; and,

WHEREAS, the County Executive recommends this transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be made within the 2014 Anti-Drug Sales Tax Fund:
