IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION transferring \$11,800.00 within the 2001 Anti-Drug Sales Tax-Deferred Prosecution Fund and authorizing the County Executive to execute a Second Addendum to the contract with County Court Services, Inc., of Kansas City, MO, for the furnishing of drug treatment services for use by the Jackson County Drug Court, in the estimated amount of \$154,000.00.

RESOLUTION # 13965, December 17, 2001

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, by Resolution 13428, dated November 13, 2000, the Legislature authorized a contract with County Court Services, Inc., of Kansas City, MO, for the furnishing of drug treatment services for use by the Jackson County Drug Court; and,

WHEREAS, by Resolution 13801, dated August 20, 2001, the Legislature authorized a First Addendum to the contract, increasing the amount by \$600,000.00, and extending the term for a period of twelve months; and,

WHEREAS, the Prosecuting Attorney has recommended an increase to this contract in the amount of \$154,000.00, in order to allow County Court Services to continue providing treatment/counseling services to participants of the Jackson County Drug Court program; and,

WHEREAS, the attached Second Addendum to Agreement provides a suitable mechanism by which to implement the Prosecuting Attorney's recommendation in this regard; and, WHEREAS, a transfer within the 2001 Anti-Drug Sales Tax Fund is necessary to provide funding for the requested increase; and,

WHEREAS, the County Executive recommends such transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be and hereby is made within the 2001 Anti-Drug Sales Tax Fund:
