AN ORDINANCE appropriating \$4,000.00 from the unappropriated surplus of the 2010 Grant Fund and authorizing the County Executive to execute a contract with the Missouri Safety Center in acceptance of the Jackson County Sheriff's Office Click It or Ticket Overtime Enforcement grant.

ORDINANCE #4207, May 3, 2010

WHEREAS, seatbelt usage among Missouri motorists averaged 76% over the past five years; and,

WHEREAS, to combat this situation, the Sheriff's Office has been awarded a grant in the amount of \$4,000.00 by the Missouri Safety Center in furtherance of the Center's Click It or Ticket Overtime Enforcement program for the period May 24 through June 6, 2010; and,

WHEREAS, the Sheriff recommends the use of funds for reimbursement of overtime used for the Click It or Ticket Overtime Enforcement program promoting the use of safety seats and safety belts throughout the County pursuant to the attached contract with the Missouri Safety Center; and,

WHEREAS, an appropriation is necessary to place the grant funds in the proper spending account; now therefore,
