IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION awarding a contract for the furnishing of software and support for use by the Management Information Systems Department to Datawatch of Wilmington, MA, at a cost to the County not to exceed \$19,231.00, as a sole source purchase.

RESOLUTION #12442, November 24, 1998

INTRODUCED BY John Patrick Burnett, County Legislator

WHEREAS, Section 1040.1 of the Jackson County Code, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends a contract with Datawatch of Wilmington, MA, for the furnishing of software and support; and,

WHEREAS, the Purchasing Director further recommends that it not take competitive bids with regard to said contract for the reason that Datawatch of Wilmington, Maine, is the only known supplier of the proprietary software and support needed; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri that the Purchasing Director be, and hereby is, authorized to execute for the County a contract with Datawatch of Wilmington, Maine, for the furnishing of software and support, in an amount not to exceed \$19,231.00; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments including final payment on the contract thereby made...Attorney  
Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
