A RESOLUTION authorizing the County Executive to execute an Agreement with DeLaSalle Education Center in the amount of \$35,000.00 on the recommendation of the Jackson County Anti-Drug Sales Tax Fiscal Commission.

WHEREAS, the Jackson County Anti-Drug Sales Tax Fiscal Commission was empowered by Ordinance #1771, #1795 and #1941 to make recommendations to the Legislature for the expenditure of Anti- Drug Sales Tax Funds for the purposes of treatment and rehabilitation of drug offenders; and,

WHEREAS, the Fiscal Commission reviewed treatment proposals during 1995; and,

WHEREAS, the Fiscal Commission has reviewed a proposal from DeLaSalle Education Center to provide an adolescent substance abuse program; and,

WHEREAS, DeLaSalle Education Center has received funding in prior years for this program upon the recommendation of the Fiscal Commission; and,

WHEREAS, the Fiscal Commission has carefully reviewed this 1996 proposal from DeLaSalle Education Center; and,

WHEREAS, the Fiscal Commission has recommended funding in the amount of \$35,000.00 from COMBAT Funds for the proposal; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to enter into the attached Agreement, a copy of which is incorporated herein by reference, with DeLaSalle Education Center; and,

BE IT FURTHER RESOLVED that the Manager of the Division of Finance be and hereby is authorized to make all payments, including final payment on the Agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
