A RESOLUTION authorizing the County Executive to execute Change Order No. 1 to the contract with R. A. Knapp Construction of Kansas City, KS, for the Noland Road Bridge over Little Blue River Project, No. 2390, at a cost to the County not to exceed \$9,246.00.

WHEREAS, by Resolution 14800, dated November 23, 2003, the Legislature did award a contrast on Bid No. PW 03-2003 to R. A Knapp Construction of Kansas City, KS, for the Noland Road Bridge over Little Blue River Project, No. 2390, at an actual cost to the County of \$1,229,837.10; and,

WHEREAS, Change Order No. 1 to the aforesaid contract, a copy of which is attached hereto, is necessary to add to this project the establishment of a field office for the joint use of the Department of Public Works and the Missouri Department of Transportation, at a increased cost to the County of \$9,246.00; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that Change Order No. 1 to the aforesaid contract is hereby approved and the County Executive is authorized to execute the change order on behalf of the county; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make

all payments, except final payment on the contract.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
