A RESOLUTION awarding term and supply contracts for the furnishing of inmate clothing for use by the Corrections Department to Acme Supply Co. Ltd. of Pt. Washington, NY, Leslee Scott, Inc., of Ogden, UT, and Uniforms Manufacturing Co. of Scottsdale, AZ, under the terms and conditions of Electronic Solicitations No. BB200577, to provide for departmental needs for the upcoming one-year period.

WHEREAS, the Director of Finance and Purchasing has solicited bids on Electronic Solicitation No. BB200577 for the furnishing of inmate clothing for use by the Corrections Department; and,

WHEREAS, a total of 51 solicitations were distributed and 11 responses were received, two of which were determined to be non-responsive for failure to submit the documentation required for award; and,

WHEREAS, following evaluation of the bids submitted, the Director of Finance and Purchasing recommends the contract be divided and awarded to the vendors submitting the lowest bid for each item; and,

WHEREAS, award as recommended would result in awards to the following vendors:
