IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE amending the zoning districts established pursuant to the Unified Development Code by rezoning a certain 8.00± acre tract from District AG (Agricultural) to District RE (Residential Estates).

ORDINANCE NO. 5803, October 16, 2023

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "AG" (Agricultural) and "RE" (Residential Estates) Districts, so that there will be transferred from District AG to District RE a 8.00± tract of land located at 31201 E. Lone Jack-Lee's Summit Road in Jackson County, MO, legally described as follows:

Description: All that part of the North Half of the North Half of the Southwest Quarter of Section 15, Township 47, Range 30, Jackson County, Missouri, described as follows: Beginning at a point 1079.35 feet east the Northwest corner of said Southwest Quarter; thence south, at right angles to the North line of said Southwest Quarter 660.02 feet to a point; thence East 567.00 feet to a point; thence North 660.05 feet to a point on the North line of said Southwest Quarter; thence West along the said North line, 567.00 feet to the Point of Beginning. Except that part in road.

<u>Section 2</u>. The Legislature, pursuant to the application of JSW Homes, LLC (RZ-2023-657), requesting the amendment embodied in this Ordinance and with notice that the Jackson County Plan Commission voted 5 to 0 to recommend <u>APPROVAL</u> of this application after a public hearing on September 21, 2023, does hereby adopt this Ordinance pursuant to the Jackson County Charter
