IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE transferring \$7,962.00 within the 2001 General Fund and appropriating \$47,262.00 from the unappropriated surplus of the 2001 Grant Fund to cover the Victim Services Volunteer Coordinator Grant for the Prosecuting Attorney's Office's Victim Services Program, received from the Missouri Department of Public Safety, and the transfer of matching funds.

ORDINANCE 3153, July 9, 2001

WHEREAS, the Missouri Department of Public Safety has awarded the Prosecuting Attorney's office a grant in the amount of \$39,300.00 as funding for its Victim Services Volunteer Coordinator Program; and,

WHEREAS, said grant is subject to a \$7,962.00 local match for which a transfer and appropriation are necessary; now therefore,
