### IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**A RESOLUTION** authorizing the County Executive to execute a cooperative agreement with Children's Mercy Hospital for its TIES program at a cost to the County of \$93,750.00 as a local match to a private grant.

**INTRODUCED BY** Dan Tarwater, County Legislator

WHEREAS, the TIES program consists of a multidisciplinary team created to identify pregnant and postpartum women affected by substance abuse and/or HIV and provides case management services to promote recovery, stabilization, and the well being of their children in a safe and drug free environment; and,

WHEREAS, the TIES program is funded by a grant awarded by the United States Department of Health and Human Services, in the amount of \$450,000.00; and,

WHEREAS, these funds are subject to a local match; and,

WHEREAS, the Prosecuting Attorney has reviewed this proposal and recommends the expenditure of these funds; therefore,

BE IT RESOLVED, by the County Legislature of Jackson County, Missouri, that the County Executive is hereby authorized to execute a cooperative agreement with Children's Mercy Hospital, as a local

grant match for the TIES program in the amount of \$93,750.00, in a form to be approved by the County Counselor; and,

BE IT FURTHER RESOLVED, that the Director of the Department of Finance be and hereby is authorized to make all payments, including final payment on the Agreement.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
