**A RESOLUTION** awarding a contract for the furnishing of DARE specialty items for use by the Sheriff's Office to DARE America (John Nadel, Inc.) of Culver City, CA (\$3,784.00) and Tee's Plus of Groton, CT (\$1,810.00), at an actual aggregate cost to the County not to exceed \$5,594.00, as a sole source purchase.

WHEREAS, Section 1040.1 of the <u>Jackson County Code</u>, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, Section 1063.00 of the Code requires notification of and approval by the Legislature on such sole source purchases exceeding \$5,000.00; and,

WHEREAS, the Purchasing Director recommends contracts with DARE America (John Nadel, Inc.) of Culver City, CA, and Tee's Plus of Groton, CT for the furnishing of DARE - licensed Specialty Items for use by the Sheriff's Office; and,

WHEREAS, the Purchasing Director further recommends that he not take competitive bids with regard to said contracts for the reason that these firms are the only qualified suppliers of the DARE-licensed specialty items required; therefore,
