IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE appropriating \$25,896.00 from the unappropriated surplus of the 2004 Health Fund and authorizing the Director of the Department of Finance to issue a check in the amount \$25,895.39 to the Mid-America Regional Council as a pass-through of funds received from the Missouri Emergency Response Commission.

ORDINANCE #3545, September 13, 2004

INTRODUCED BY Robert A. Stringfield, County Legislator

WHEREAS, under Title III of the Superfund Amendment and Reauthorization Act, enacted by Congress in 1986, the County joined with other units of local government in the area to form the Mid-America Local Emergency Planning Committee, which is operated by the Mid-America Regional Council (MARC); and,

WHEREAS, the operations of such committees are funded by the proceeds of a fee paid to the states by companies who maintain or store hazardous wastes at their facilities; and,

WHEREAS, the Missouri Emergency Response Commission has remitted to the County the sum of \$25,895.39 as its share of these funds; and,

WHEREAS, the County is required to provide these funds to MARC to support the activities of the Mid-America Local Emergency Planning Committee; now therefore,
