IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION approving the purchase of industrial pipe fitting and plumbing supplies for use by the Parks and Recreation, Public Works, and Facilities Management Departments from Riback Supply Co. of Kansas City, MO, and Ferguson Enterprises, Inc., of Kansas City, MO, under a City of Kansas City, MO government contract, at an estimated aggregate cost to the County of \$40,000.00.

RESOLUTION 13809, August 27, 2001

INTRODUCED BY Ronald E. Finley, County Legislator

WHEREAS, the County desires to purchase industrial pipe fitting and plumbing supplies for use by the Parks and Recreation, Public Works, and Facilities Management Departments; and,

WHEREAS, the Director of Purchasing pursuant to Section 1040.04 of the Jackson County Code, 1984 desires to make this purchase from Riback Supply Co. of Kansas City (Jackson County), MO, and Ferguson Enterprises, Inc., of Kansas City (Jackson County), MO, under an existing City of Kansas City, MO government contract; and,

WHEREAS, Section 1064.00, Jackson County Code, 1984 requires that for any such purchase in excess of \$5,000, the Director of Purchasing shall submit the purchase to the County legislature for approval; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the purchase under the existing government contract be made as recommended by the Purchasing Director, and that the Purchasing Director be, and is hereby, authorized to execute for the County any documents necessary to the accomplishment of the purchase; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent that sufficient appropriations to the using spending agencies have heretofore been made in the current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
