**AN ORDINANCE** appropriating \$125,000.00 from the undesignated fund balance of the 2014 General Fund and \$90,000.00 from the undesignated fund balance of the 2014 Delinquent Sales Tax Fund to cover the cost of unanticipated legal expenses.

WHEREAS, certain unanticipated legal expenses have exhausted available funds within the nondepartmental legal services budget; and,
