IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

AN ORDINANCE appropriating \$142,240.00 from the unappropriated surplus of the 1995 County Urban Road System Fund and authorizing payment of \$142,240.00 as the commissioners' award in the condemnation case, "Jackson County, Missouri vs. Rosie Burns, et al." (CV95-6317).

ORDINANCE #2453, September 11, 1995

INTRODUCED BY Victor E. Callahan, County Legislator

WHEREAS, Tom Hayes, Jr, James Flanagan and Carl Bolte, Condemnation Commissioners previously appointed by the Judge of Division No. 1 of the Circuit Court of Jackson County, Missouri in Condemnation Case No. CV95-6317, entitled, "Jackson County, Missouri vs. Rosie Burns, et al.", did on the 31st day of August, 1995, file their written report pursuant to law with the Circuit Court in Jackson County, Missouri, assessing damages in favor of the various parties defendant in said case in the aggregate amount of one hundred forty-two thousand, two hundred forty dollars (\$142,240.00); and,
