IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

A RESOLUTION congratulating Judge Gene R. Martin on his 19 years as a Jackson County, Missouri circuit judge, and wishing him well on his retirement.

RESOLUTION # 11298, May 20, 1996

WHEREAS, Gene R. Martin was born on July 18, 1926, in Kansas City, Missouri, where he received his public education; and,

WHEREAS, prior to his legal career, Judge Martin served in the United States Army Air Corps from 1943 to 1945; and,

WHEREAS, Judge Martin received his J. D. degree from the University of Missouri-Kansas City in 1953; and,

WHEREAS, while obtaining his law degree, Judge Martin served as a deputy court clerk in the United States District Court for the Western District of Missouri from 1951-1953, and after being admitted to the bar became associated with Wilbur B. Ennis, with whom he later formed a partnership known as Ennis, Browne & Martin; and,

WHEREAS, Judge Martin continued his practice of law with this firm until his appointment to the 16th Judicial Circuit bench in Jackson County on December 21, 1976; and,

WHEREAS, during his judicial career, Judge Martin served as Presiding Judge from 1989 to 1990; and,

WHEREAS, Judge Martin is a member of the Missouri Bar, an honorary member of the Kansas City Metropolitan Bar Association and the Lawyers Association of Kansas City, MO, and has served as a member of the Missouri Supreme Court's Judicial Education Committee, Executive Council of the State Judicial Conference, Executive Committee of the State Presiding Judges, and Missouri Press-Bar Commission; and,

WHEREAS, he serves on the Board of Trustees of the University of Missouri-Kansas City Law Foundation, has served on numerous circuit court committees, and served as secretary of the KCMBA in 1974-75 and in 1990, and was honored with the Presidential Recognition Award; and,

WHEREAS, Judge Martin is a member and elder of the Hickman Mills Community Christian Church; and,

WHEREAS, he married the former W. June Wells on June 4, 1950, and they have two sons and four grandchildren; and,

WHEREAS, the judge's favorite hobbies include sailing, traveling, photography, and water and snow skiing; and,

WHEREAS, Judge Martin has distinguished himself through his unparalleled service to the citizens of Jackson County, Missouri as a circuit court judge; therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Legislature congratulates Judge Gene R. Martin on his 19 years as a Jackson County circuit judge and wishes him success and satisfaction in all of his future endeavors...Attorney Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
