WHEREAS, the Purchasing Director has solicited bids by Electronic Solicitation No. BB200123 for the furnishing of blue grass and zoysia sod for use by the Parks and Recreation Department; and,

WHEREAS, after evaluation of the bids submitted, he has recommended that the contract be split and awarded to the vendor submitting the lowest bid for each item; and,

WHEREAS, award as recommended would result in estimated awards to the following vendors:

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent that sufficient appropriation to the using spending agency has heretofore been made in the current Jackson County budget.
