WHEREAS, the Missouri Department of Public Safety has awarded a Victim Advocacy Grant in the amount of \$46,738.00 to the Prosecuting Attorney's Office to cover the salary and benefits for a victim advocate for its Victim Advocacy Program; and,

WHEREAS, an appropriation is necessary to place the grant in the appropriate spending accounts; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,
